



# Interagency Treatment Dashboard Reporting Entity Data Notes

- Timber Companies
  - Data source: California Forestry Association (Calforests) internal systems
  - Notes: This data was provided in tabular format summarizing statewide activities and therefore does not contain spatially explicit polygons displaying treatment extents. Dashboard views which filter data geographically (e.g. by Task Force Region or by County) therefore exclude timber companies' activities. Timber company data is viewable by querying the points off the coast of California. This data only includes information collected by Calforests, which is not comprehensive of all California timber companies nor activities.
- CAL FIRE
  - Data source: CalMAPPER
  - Notes: Treatment acres reported in [CAL FIRE's Fuel Reduction Projects Viewer](#) may differ from those displayed in the Task Force Dashboard. CAL FIRE's Viewer reports by the state fiscal year (July-June), only includes treatments related to fuels reduction, and includes work measured in units such as hours and tons. The Task Force Dashboard is based on calendar year, includes a wider suite of activities, such as tree planting, and only reports work measured in acres.
- U.S. Forest Service
  - Data source: Forest Activity Tracking System (FACTS)
  - Notes: Treatment acres reported in FACTS differ from those displayed in the dashboard. FACTS is based on the federal fiscal year (October-September) and includes a broad array of activities including but not limited to vegetation management. The Task Force Dashboard is based on calendar year and only shows treatments as accomplished when they have been completed on-the-ground, rather than when the activities are contracted.
- CA Department of Transportation
  - Data source: Caltrans internal systems
  - Notes: Some vegetation management work conducted by Caltrans is not included in the dashboard because it is not reported in acres (for example, hazard tree removal)



- CA Department of Fish and Wildlife
  - Data source: California Natural Resources Agency (CNRA) Treatment Tracker
  - Notes: CNRA departments and Conservancies are currently submitting and validating data for the second half of calendar year 2022. Some activities from this time period are not included in the Dashboard and will be refreshed with updated numbers throughout 2023.
- U.S. Fish and Wildlife Service
  - Data source: [National Fire Plan Operations and Reporting System \(NFPORS\)](#)
- Bureau of Land Management (BLM)
  - Data source: BLM internal systems
- Department of Defense
  - Data source: Prescribed Fire Information and Reporting System (PFIRS)
  - Notes: This data only includes prescribed fire activities completed by the Department of Defense, and does not represent other activities that they carry out with cooperating agencies.
- CA State Parks
  - Data source: CNRA Treatment Tracker
  - Notes: CNRA departments and Conservancies are currently submitting and validating data for the second half of calendar year 2022. Some activities from this time period are not included in the Dashboard and will be refreshed with updated numbers throughout 2023.
- National Park Service (NPS)
  - Data source: NPS internal systems
- Tahoe Conservancy
  - Data source: CNRA Treatment Tracker
  - Notes: CNRA departments and Conservancies are currently submitting and validating data for the second half of calendar year 2022. Some activities from this time period are not included in the Dashboard and will be refreshed with updated numbers throughout 2023.
- San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy
  - Data source: CNRA Treatment Tracker
  - Notes: CNRA departments and Conservancies are currently submitting and validating data for the second half of calendar year 2022. Some activities from this time period are not included in the Dashboard and will be refreshed with updated numbers throughout 2023.
